



## WARRANTY

KEWAUNEE SCIENTIFIC CORPORATION warrants for a period of one (1) year from the date of substantial completion that all (*Insert Product Name* ) products, sold through authorized dealers, shall be free from defects in material and workmanship. This warranty shall not be assigned or benefit any third party without written consent by Kewaunee Scientific Corporation, and this warranty shall be void as to any assignment in violation of this provision. This warranty shall be void if such products are not properly installed according to published instructions by Kewaunee or industry acceptable practices such as those published by SEFA (Scientific Equipment Furniture Association).

Purchaser shall notify Kewaunee immediately of any defective product within the warranty period. Kewaunee shall be given reasonable opportunity to inspect to determine the nature and source of the defect. This warranty does not cover (i) the cost of labor, material or services contracted by purchaser; (ii) normal wear and tear, (iii) improper shipping / handling, failure to install, reconfigure, or (iv) improper maintenance abuse, misuse, accident (including but not limited to use of product in unsuitable environments or conditions), or alteration or modification of the product. No product shall be returned to Kewaunee until receipt by purchaser of written shipping instructions from Kewaunee.

THE PURCHASER'S EXCLUSIVE REMEDY AND KEWAUNEE'S SOLE LIABILITY SHALL BE, AT KEWAUNEE'S SOLE OPTION, REPAIR OR REPLACEMENT OF THE NON-CONFORMING PRODUCTS OR THEIR PARTS BY KEWAUNEE OR AUTHORIZED DEALER OF KEWAUNEE. KEWAUNEE SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES, LOSSES OR EXPENSES WHETHER INCURRED IN CONNECTION WITH INJURY TO PERSONS OR PROPERTY. IN NO EVENT SHALL KEWAUNEE'S LIABILITY EXCEED THE PURCHASE PRICE OF THE PRODUCT(S) PAID BY PURCHASER IN THE PRECEDING TWELVE (12) MONTH PERIOD PRIOR TO THE SPECIFIC WARRANTY CLAIM AT ISSUE. KEWAUNEE MAKES NO OTHER WARRANTY, EXPRESS OR IMPLIED, WRITTEN, OR ORAL, INCLUDING, BUT NOT LIMITED TO, MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE.
